Membership categories:

Individual £15 per annum: Free entry to lectures, privileged admission to the annual CGS Spring Flower Show, a copy of the annual journal, garden visit details, regular newsletters, discounted admission to nominated gardens in Cornwall and discounts at many nurseries and garden centres.

Family (two members of a household) £22.50 per annum: as above for two members of the family. (To add other members of the family who live at the same address, please add £4 per person, per annum).

Student (in full-time education) £7.50 per annum: as for Individual Members.

Fellows £25 per annum: as for Individual Members but with two membership cards for Fellow and guest.

Life £300: as for Individual Members but with two membership cards for Life Member and guest.

Affiliated Societies £15 per annum: includes two free membership cards for use by any of the Society's members, Gold and Silver Gilt certificates from the CGS to award at the Affiliated Society's shows, opportunities to share lectures in their area with the CGS and regular mailings.

Trade Members £20 per annum: professional horticulturists who join as Trade Members are given priority in the allocation of space for trade exhibits at CGS shows, free passes for two exhibitors on the Trade Member's stand at CGS shows, the opportunity to participate in CGS activities and regular mailings.

Terms & Conditions

The Cornwall Garden Society is delighted to welcome new members at any time of year. Membership is renewable annually on 1 January, irrespective of the month of the year in which you join. Upon receipt of your completed Membership Form and the appropriate payment, we will issue you with a membership card that will be valid until 31 December in the year in which you join. Renewal of your membership will take place annually on 1 January by Direct Debit. Please complete the Direct Debit Form on the next page (retaining the tear-off slip) and return it to the Membership Secretary with your completed Membership Form. Please do not return your completed Direct Debit Form to St Denys House (the registered address of The Cornwall Garden Society).

We will write to you each December to remind you that we will be collecting your subscription to renew your membership on 1 January by Direct Debit unless you instruct us not to do so.
